The consultants will lead continued discussion on the Growth Concept maps, and will facilitate dialogue on comments which were voiced during the April 28 meeting including:

- Land use classifications (what do they mean? How will they integrate with existing land use classifications)
- Infill opportunities (how to entice infill)
- Social needs (how will the Plan address the special needs of the poor and disadvantaged)

The GPURC will have the opportunity to comment or ask questions on the Growth Concept maps prior to commencing public dialogue in the community meetings on May 10.
